- Vendors are required to check in at the registration table upon arrival. Set up prior to 7:30 am is prohibited. Breakdown must be completed by 2:00 PM. Booths must be left clean and trash free. Vendors are responsible for protecting their property and merchandise from damage or loss. We reserve the right to remove and/or deny future application to any vendor who exhibits improper behavior toward swap meet staff, patrons, and/or other vendors.
- ALL SPACES ARE PRE-ASSIGNED. If you have not checked in by setup time, your assigned space may be given to someone else and you will be reassigned on a first come, first served basis. All space assignments will be located in The Community Center & the open air stables behind it. Food Trucks will be parked in the lot by the building entrance within the parking lot. Food Booths in front of Center on pavement under eaves.
- All vendors are responsible for the disposal of all boxes, packing materials, and trash. NOTHING is to be left behind that you brought with you. Candles or other flammable items may not be burned in the building. Smoking, alcoholic beverages, pets, gas or electric powered generators are NOT permitted inside the center.
- All displays must remain entirely within the space provided. Aisle space must not be infringed upon. Storage must be covered and out of sight. No nails , thumbtacks, screws, or other sharp pointed implements may be used / driven into floors, walls, posts, tables, or any part of the building structure. Please bring any tape you may need to construct your display.
- No Parking on the grass, overflow parking on the street. Stables vendors may park in back & unload by driveup on back lane. Fenced areas are off limits.
- Hawaiian Shores Community Association & Dawn Hurwitz will not be liable for any damages or injury to persons or property, sustained by conditions or activities on the premises.
